Edit a clause

You (primary owner) can edit an existing clause at any state. For example, you can edit a clause that is in **Approved** state. However, you have to go through the approval process again. You can add or remove, and make the appropriate changes in the clause.

You can edit the probation period clause you just created.

To edit a clause:

- 1. On the ICM Dashboard, click **Clauses.** The **Clauses** page appears.
- 2. On the Clauses page, Search Payment Terms Clause that you want to edit and then click
